| <p><u>1.Selection to the post of Chief Engineer. (L-I)</u> Selection to the post of Chief Engineer (L-I) and other equivalent posts as may be specified by the Board in the cadre of the service shall be made from amongst such Chief Engineer (L-II) who have put in not less than 6 years service as Chief Engineer(L-II)/Superintending Engineer as such on the 1st July of the year in which <u>selection is made.</u></p> <p><u>2. Selection to the post of Chief Engineer (Level-II)</u> Selection to the post of Chief Engineer (Level-II) and other equivalent posts as may be specified by the Board, in the cadre of the Service, shall be made from amongst Superintending Engineers who have put in 4 years service as such on July 1 of the year of selection.</p> | <p><u>1.Selection to the post of Chief Engineer. (L-I)</u> Selection to the post of Chief Engineer (L-I) and other equivalent posts as may be specified by the Board in the cadre of the service shall be made from amongst such Chief Engineer (L-II) who have put in not less than 12 years service as Chief Engineer(L-II)/Superintending Engineer/Excutive Engineer as such on the 1st July of the year in which <u>selection is made.</u></p> <p><u>2. Selection to the post of Chief Engineer (Level-II)</u> Selection to the post of Chief Engineer (Level-II) and other equivalent posts as may be specified by the Board, in the cadre of the Service, shall be made from amongst Superintending Engineer who have put in 10 years service as Superintending Engineer / Executive Engineer as such on July 1 of the year of selection.</p> |

3. Selection to the post of Superintending Engineer.

Selection to the post of Superintending Engineer and other equivalent posts, as may be specified by the Board, in the cadre of the service shall be made from amongst the Executive Engineers who have, on July 1 of the year of selection, put in minimum of 15 years Service on the post of Assistant Engineer and higher posts under the State Govt. or the Board.

Provided that out of the above 15 years, at least 6 years service must have been rendered on the post of Executive Engineer and or other equivalent post;

Provided further that officers who have rendered not less than 6 years service as Executive Engineer as above may be considered eligible for appointment to temporary and officiating posts of Superintending Engineers even if they have rendered less than 15 years service on the post of Assistant Engineer and higher post.
