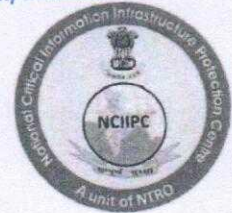

NCIIPC is organising the third National Level Critical Information Infrastructure (CII) Security Exercise named CII SECEX 2025 from 11-20 April 2025. The exercise will be in three tracks as mentioned below:

i. **Track-1: Cyber Security Training and Operational Exercise**

This program will encompass 06 days (11-16 April 2025) hands on training followed by 03 days (18-20 April 2025) hands on operational exercise (17 April will be break day) held simultaneously at 4 locations across the country viz. Delhi, Mumbai, Bengaluru & Kolkata. There will be 03 parallel training and operational exercise sessions for participants viz IT, OT and SOC. Each nominated officer can participate in one of these three tracks based on their work area/ skills requirement.

ii. **Track 2: Advanced Operational Exercise**

This year NCIIPC has introduced two parallel advanced level operational exercises on IT and SOC themes. This is a 3 day program aimed at participants who have sufficient knowledge and skills in IT (Data Centre, Cloud operations, IR Team, Threat Hunting team etc.) and SOC related work. Both these advanced exercises will be held during 18-20 Apr 2025 simultaneously at New Delhi and Mumbai. This would help organisations and their Cyber Defenders to beef up their skills to defend against the latest and most sophisticated threat scenarios.

iii. **Track 3: Strategic Exercise**

A 2-day long exercise for Senior Management level officials (Viz. CISO, CTO, CRO etc.) of Critical Sector Entities dealing with Cyber Security related issues and policies will be held during 19-20 Apr 2025 at New Delhi.

2. These exercises have been designed to provide your officials a unique opportunity to assess and improve their cyber defensive skills and facilitate exchange of best practices among the peers.
